AUSTRALIA'S BIOMEDICAL INDUSTRY HUB

NSW is an international leader for the biomedical sector and recognised as the epicentre of Australia's medical device industry.

The biomedical sector is an important contributor to the State's economy, with strengths in diagnostics, medical devices, pre-clinical and clinical trials, human therapeutics and vaccines.

Companies of all sizes located in NSW operate at the international forefront of their respective biomedical fields, from established international leaders, such as Cochlear Ltd (hearing devices) and ResMed (respiratory devices), through to companies developing cutting-edge technology to capitalise on emerging markets.

NSW is home to 78 per cent of multinational pharmaceutical companies in Australia¹, 45 per cent of Australia's medical devices companies and 27 per cent of core biotech companies².

In 2009–10, A\$2.5 billion of medical equipment, pharmaceuticals and medicinal products were exported from NSW alone, with the State accounting for 71 per cent of Australia's total medical equipment exports³.



A STATE OF CONSTANT DISCOVERY

NSW has world-class biomedical research institutions which foster excellence and drive innovation to achieve health, environmental and economic outcomes.

NSW is home to 11 universities and eight Australian Research Council Centres of Excellence, including Cognition and Disorders, Population Ageing Research and Electromaterials. NSW also boasts more than 70 biomedical research centres, supported by 11 major teaching hospitals.

The State's outstanding biomedical research infrastructure supports NSW companies, from start-ups to international market leaders, to excel across all biomedical fields.
