## BUSINESS MIGRATION REQUEST FOR NSW GOVERNMENT STATE SPONSORSHIP

### DECLARATION BY APPLICANT OR MIGRATION AGENT

#### Limitations of State Sponsorship

NSW is keen to attract talented and energetic business migrants in general and in areas of strategic economic value to the state in particular.

Obtaining State Sponsorship is one step on the path for particular classes of business migrants to obtain an Australian visa. All applications are treated on their merits and applicants who meet State and Commonwealth criteria and submit a properly documented application have a reasonable chance of success. However **such success is never guaranteed**, either at the outset or during the processing of any application.

Industry & Investment NSW requires that applicants applying for NSW State Sponsorship acknowledge the limitations of such sponsorship. You should be aware that:

- \* The Commonwealth of Australia, not individual states, has sole responsibility for granting visas to enter, or stay in, Australia;
- \* Approval of NSW state sponsorship for a particular applicant by Industry & Investment NSW does not constitute the granting of a visa to enter, or stay in, Australia;
- \* Approval of NSW state sponsorship by Industry & Investment NSW does not in any way imply that a visa application will be approved by the Commonwealth of Australia; and
- \* Approval of NSW state sponsorship by Industry & Investment NSW does not imply that the State of NSW will automatically approve subsequent applications for state sponsorship. For example if Industry & Investment NSW approves State Sponsorship of a Provisional visa for an applicant it DOES NOT mean that Industry & Investment NSW will automatically approve a subsequent application for NSW state sponsorship of a Residence visa.

#### Information Sharing with the Commonwealth

From time to time and for the purposes of assessing an application for State Sponsorship it may be necessary for Industry & Investment NSW to share information about your application with various Commonwealth Government agencies (the Commonwealth). This information sharing will only be used, where relevant, to carry out further investigations with the Commonwealth to assist the State of New South Wales in reaching a decision on state sponsorship and for no other purpose.
